## NONIMMIGRANT VISAS

### O-1

#### Exceptional abilities

Investment amount:

**Not required**

Review time:

**15 days**

Options to switch to a Green Card:

**EB-1A, EB-2, EB-3**

**For those who possess extraordinary ability in the sciences, arts, education, business, or sports.**

#### Basic requirements:

- Mandatory advisory opinion from the relevant industry organization in the United States;
- A valid job offer from an American company;
- Documents demonstrating national or international recognition of the applicant in the field of his/her outstanding achievements for at least 3 criteria.

## IMMIGRANT VISAS

### EB-2NIW

#### National Interest Waiver

Investment amount:

**Not required**

Review time:

**6-9 months**

**For those who have exceptional abilities in the sphere that falls under U.S. national interests.**

Basic Requirements:

- Master's or Bachelor's degree with 5 years of work experience OR exceptional talent (satisfy 3 visa criteria out of 6)

### EB-1A

#### Exceptional abilities

Investment amount:

**Not required**

Review time:

**15 days**

For those who demonstrate outstanding abilities in science, art, education, business, or sport.

Basic requirements:

- Documents that demonstrate national and international recognition of the applicant in the field of his outstanding achievements for at least 3 criteria;
- Continued work in the field of applicant's excellence;
- The level of achievements required is higher than for the O-1 visa.

# O-1 NONIMMIGRANT VISA FOR PEOPLE WITH OUTSTANDING ABILITIES

To qualify for an O-1 visa, you must have extraordinary ability in the sciences, arts (including movies and television), education, business, or athletics.

Documentation must be provided to substantiate outstanding achievement or ability. The proof of such abilities and achievements is confirmed by documents evidencing the international or national recognition of the applicant.

# O-1

## KEY BENEFITS OF THE O-1 VISA

01

A quick path to obtaining the right to temporarily live and work in the United States for individuals with outstanding achievements in science, education, business, arts, or sports.

02

Expedited review time that makes it possible to get the visa in 15 days.

03

The level of achievements required is lower than for the EB-1A visa.



## OTHER BENEFITS FOR O-1 VISA HOLDERS

- ❖ No need to invest money to apply for a visa.
- ❖ The O-1 visa is not subject to annual quotas.
- ❖ The applicant's family (spouse and unmarried children under 21) is entitled to live and study in the United States for the duration of the applicant's visa.

## BASIC REQUIREMENTS FOR O-1 VISA

- ❖ The applicant must demonstrate excellence in the sciences, arts, education, business or sports through proven national or international recognition.
- ❖ To apply for this visa, the applicant must provide a mandatory written opinion from the relevant industry organization in the United States.
- ❖ A valid job offer from a U.S. company is required.

## O-1 VISA EXTENSION:

- ❖ Initially, the O-1 visa is usually issued for up to 3 years (depending on the length of the employment contract).
- ❖ In the future, the visa can be renewed annually.
- ❖ The number of extensions is not limited.
- ❖ Opportunity to get a Green Card for the whole family through the change of status to EB-1A, EB-2 NIW and EB-3 visas

# EB-1A IMMIGRANT VISA FOR PEOPLE WITH OUTSTANDING ABILITIES

The EB-1A immigrant visa allows foreign nationals with outstanding abilities in the sciences, arts, education, business, or sports to apply for a Green Card in the United States. Your achievements must be recognized at the national or international level and must be confirmed by relevant documentation in a relevant field.

# EB-1A

## KEY BENEFITS OF THE EB-1A VISA

01

The ability to apply for a Green Card (permanent residence) immediately.

02

Opportunity to obtain a permanent Green Card under the expedited review in 15 days.

03

A valid job offer from a U.S. employer is not required.

## OTHER BENEFITS FOR EB-1A VISA HOLDERS

- ❖ No need to invest money to apply for a Green Card.
- ❖ Opportunity to live and work in the U.S. while the petition is pending approval by USCIS.
- ❖ The applicant's family (spouse and unmarried children under 21) also receive a Green Card.

## BASIC REQUIREMENTS FOR THE EB-1A VISA

- ❖ The applicant may file a petition on his/her own behalf without the need for a U.S. employer.
- ❖ The applicant must demonstrate excellence in the sciences, arts, education, business, or sports through proven national or international recognition.
- ❖ The applicant must confirm that he/she will continue to work in the area where his/her outstanding abilities are manifested

## OBTAINING A GREEN CARD

After the approval of the petition for an EB-1A visa, a Green Card is issued, which does not require any extensions or confirmations.

## EB-1A VISA CRITERIA

- ❖ National and international awards
- ❖ Participation in professional organizations, and associations, that only accept for high achievements
- ❖ National and international media
- ❖ Your own articles in major or professional publications
- ❖ Books, manuals, patents, exhibitions of works showing your contribution to the industry
- ❖ High salary or tax reporting on your income
- ❖ Participation in judging or evaluating the work of other participants
- ❖ Your leading position or critical role in a reputable company
- ❖ Letters of recommendation
- ❖ Commercial success

## IMMIGRANT VISA EB-2NIW (NATIONAL INTEREST WAIVER)

What is required from you to receive a GREEN CARD for the whole family under the EB-2NIW program?

✓ Education: Master's or Bachelor's degree with 5 years of work experience

✓ OR any 3 criteria of the following:

- Official confirmation of higher education in the profession from an educational institution: diplomas, certificates in the field of exceptional abilities.

1. Documented 10 years of work experience in the profession: letters of recommendation from employers.
2. Licenses or certificates for your activities.
3. Evidence of a high salary or other rewards for activities in the professional field: copies of employment contracts, and agreements.
4. Have supporting documents showing membership in a trade union organization.
5. Confirmation of achievements and significant contribution in the professional field from government agencies, colleagues, companies, and professional organizations.

You must prove that you will benefit the United States. Evidence of how your abilities will help improve the U.S. economy, culture, public health, or science.

# EB-2NIW

## KEY BENEFITS OF THE EB-2NIW VISA

01

Ability to apply for a visa while being in the USA if you are already in the U.S. with legal status.

02

Falls under the category of work visas and doesn't require investments.

03

Possibility of expedited review

## ADDITIONAL BENEFITS OF THE EB-2NIW VISA

01

Does not require to have a U.S. employer.

02

Gives you the right to get a U.S. Green Card.

03

The applicant's family (spouse and unmarried children under 21) also receive a Green Card.
